## APPLICATION PROCEDURE

Listed below are the documents that you are required to provide when applying.

<u>IMPORTANT</u>: In order to process your application, you <u>MUST SUBMIT</u> THE <u>FOLLOWING DOCUMENTS (FOR YOURSELF AND EACH PERSON</u> who will live with you.) Failure to provide the information below, will delay/stop processing!

- I. Proof of residency copy of lease and rent receipts for the last three months or <u>NOTARIZED</u> letter from landlord or homeowner allowing you to reside at that address. (P.O. Box Numbers as your address are not acceptable!)
- 2. Original Birth or baptism certificates and original Social card(s) for everyone on application. Proof of legal entry or Alien Status needed if not a U.S. Citizen.
- 3. Proof of last 10 weeks wages, pension, welfare assistance (DPW), social security or SSI benefits, child support, voluntary support (NOTARIZED letter from person providing support) and any other income for all household members age 18 or older.
- 4. A copy of latest bank account statements and/or any investments.
- 5. Current GAS and ELECTRIC utility bills.
- 6. Marriage certificate or NOTARIZED Common Law Statement.
- 7. Employer's name, address and telephone number.
- 8. Landlord's name, address and telephone number.
- 9. If you are a property owner, you must provide a copy of a Realtor's estimated property value, the most recent Agreement of Sale, current tax bills with assessment stated.
- 10. A copy of any bankruptcy documents.
- 11. Driver's license and car registration.
- 12. Picture ID.
- 13. Proof of pregnancy.
