That concludes committee reports. We'll now go into **Resolutions.** We have <u>Review and Award Contract for HVAC projects in the High Rise</u>. I'll read the information.

On Wednesday, April 18th, a bid opening was held for two HVAC projects at the high rises. This work includes installing an air conditioning system in the elevator equipment room at Monocacy. This is needed for the new elevator control equipment, which is more temperature sensitive than the old equipment. Also included is a project to install boiler controls at Bodder, Bartholomew and Litzenberger. These controls will modulate the heating water temperatures based on the outside air temperature.

The low bid in the amount of \$63,000.00 was submitted by KC Mechanical Service, Inc., of Mt. Bethel, PA. They have worked for us in the past and they're recommended by the Director of Capital improvements, Mr. Kichline.

Do I hear a motion to accept that?

It has a year warranty. That's what most construction work contracts have, one year.

Ortiz-

I have a question on the elevator. Did they ever start with the demo work? Gonzalez-

They're still in the engineering phase of the work, you know ordering equipment. And I think they did a little demo work, did they Curt?

Kichline-

The equipment is ordered and until certain parts show up there's no need to take anything apart because there is nothing they can do. So it'll probably be another four weeks until the equipment is here and they can start.

Linares-

I was waiting for the elevator to come down and it just went right pass me. One gentleman, I guess the janitor said they've been having problems with it.

Gonzalez-

That's news to us about the problems because it's been working relatively well.

Schuster-

We did have a door issue called in to the maintenance staff today and we're addressing the door issue. That's all I know about the elevators.

Gonzalez-

As a part of that project, the successful bidder Current Elevator Company to over the maintenance for this building. We cancelled Otis's contract for this building only. Therefore, the new company that took over everything took over the maintenance part of it too. We have been calling Current Elevator Company now.

The low bid in the amount of \$65,460.00 was submitted by Spotts Brother, Inc., of Schuylkill Haven, PA.
